Purpose of the course unit (module): programme competences to be developed

The main objective of the course is gaining theoretical knowledge about the institutions of European Civil Procedure Law, aims of their application and implementation. The course aims to enable the student to evaluate the position of European Civil Procedure in the overall system of Civil Procedural Law, its basic operating principles and basic issues of court jurisdiction, recognition and enforcement of judgments, service of documents, taking of evidence, functioning of the special ("autonomous") procedures and harmonization of national law by means of EU procedural Directives.

To achieve a deeper analysis of European Civil Procedure and considering the importance of practical use of knowledge, special focus is given to continued examination of relevant case law of the European Court of Justice and recent EU legislative proposals in the given area.
