Group research work	10	During semester	During the semester, written group research work related to the analysis of the application and implementation of the international humanitarian law is carried out. Structure and scope of work; content (whether the analysis is comprehensive, systematic, with appropriate arguments); used sources; the fluency of language and use of legal terms are evaluated.
Examination	70	At the end of the course	Answers to closed questions in the form of a test, in which students must demonstrate both knowledge and understanding of the international humanitarian law and demonstrate newly acquired skills. Each correctly answered question out of 10 is evaluated by 1 point (multiplied by 0.7).
