The examination questions will reflect to legal topics discussed in the lectures and seminars and will consist of multiple choice (50%) and short essay (50%) questions: <ul> <li>Questions in multiple choice part will have the same weight for the examination grade. The assessment of multiple-choice questions will be aimed at the student's capability of creative thinking and problem solving, based on the knowledge of the subject and abilities acquired during the course; and</li> <li>Two essay-type questions will have the same weight for the examination grade (25%). The assessment will be based on the student's capability to write in a logical, clear and well-structured manner, to support his/her arguments with the relevant legal provisions and case-law, to analyse various opinions of the academicians and be able to support the most appropriate view, which would be based on student's own reasonable and convincing argumentation.</li> </ul> </li> </ul>
