			 a content of the presentation (comprehensive problem analysis, proper application of the laws and case-law on the competition law, critical analytical thinking, and conclusion/recommendation formulation); a structure and style of the presentation (clear structural parts, scientific language style, exact wording, source references, proper and ethical citation use; the use of informative visual aids); efficient and active participation in a discussion, answering to questions with the well-grounded legal arguments.
Examination	60	At the end of the course	The examination in written will be open book and open note. The examination questions will reflect to legal topics discussed in the lectures and seminars and will consist of multiple choice (50%) and short essay (50%) questions: - Questions in multiple choice part will have the same weight for the examination grade. The assessment of multiple-choice questions will be aimed at the student's capability of creative thinking and problem solving, based on the knowledge of the subject and abilities acquired during the course; and - Two essay-type questions will have the same weight for the examination grade (25 %). The assessment will be based on the student's capability to write in a logical, clear and well-structured manner, to support his/her arguments with the relevant legal provisions and case-law, to analyse various opinions of the academicians and be able to support the most appropriate view, which would be based on student's own reasonable and convincing argumentation.
