<p>The subject of the problems of the European Union (EU) institutional law is to develop the ability to study and assess the nature of the European integration process, the development of the EU institutional and legal system, the specifics of the gradually formed EU institutional and legal system, and interaction with the national institutional and legal systems.</p> <p>Topics analyzed: the guiding principles underpinning the EU (powers conferred, subsidiarity and proportionality, respect for the national identities of the Member States, etc.), the limits of the powers conferred on the EU to balance EU powers, and the case-law of the Court of Justice and the effectiveness of the law, respect for national identities, the compatibility and interrelationship between EU and national law.</p> <p>Upon completion of the course, the doctoral student will have the necessary theoretical and practical knowledge of the EU system of institutional legal categories, the peculiarities of their competencies and their interpretation in legal doctrine, the legislative process and jurisprudence. During the course, the doctoral student will develop critical skills in the analysis of legal acts and case law, will be able to analyze the selected EU institutional law problem in a broader context of theoretical legal problems, apply various legal research methods to assess and solve theoretical and practical EU institutional law problems.</p>
