**Comprehensive Justice for Ukraine: State Responsibility and Individual Accountability**

The panel will address international justice efforts aimed at ensuring individual criminal responsibility for international crimes, including the crime of aggression, from investigations in national jurisdictions to those at the International Criminal Court and the Special Tribunal for the crime of aggression. Forums of state responsibility (reparations) will also be discussed, including the case of Ukraine against Russia before the International Court of Justice and the establishment of a Register of Damage as the first step in an international reparations mechanism.
