## **ABOUT THE COURSE**

Cultural heritage and Art law is a broad and fascinating field of law comprising two significant subsets: tangible and intangible cultural heritage as a legacy of our ancestors and our collective memory and cultural objects in terms of their commercial value and circulation on the market. The field covers classical and modern art, antiquities and new technologies, books and folklore, underground and marine archaeology, architecture, monuments, treasure, public and private sales, and much, much more. It helps to preserve our identity and operate as a skilled market player. Moreover, art objects' record-setting prices make it a luxury sphere which never underestimates knowledgeable advice.

This course is built on the initiative of the successful intensive course on "Introduction to Art Law in the Baltic-Nordic Region" held in the summer of 2016. The course was highly rated among professionals. Due to strong interest from law specialists this follow-up one day seminar focuses more on the practical side with case studies of art law issues. The seminar will cover four trending topics with four experts from the state sector and the academic field as well as practitioners.

For a long time he worked in law enforcement sector. Andris also has work experience in justice and museum field. He is a manager, co-author and reseracher in a range of national and international research projects related to illegal turnover of cultural objects. Andris is a member of IBA and European Association of Archaeologists.

**Merima Bruncevic (LL.D)** is a researcher and senior lecturer at the Gothenburg University, Sweden. She is currently also working at the University Roma Tre in Italy on her postdoctoral research on cultural property. Merima is an author of a book "Modern Intellectual Property Law". Merima worked for a long time as Intellectual Property Manager at the Walt Disney Company in London, UK, as well as held various other legal posts in the music and film industries.

**Ms Vilte Kristina Steponenaite (LL.M)** is teaching European Union law at Vilnius University. She also has more than five years experience in the leading law firms in the Baltics providing largest local and multinational businesses with number of solutions for complex contracts, intellectual property, information technology, privacy and data protection, advertising, entertainment and media law related projects across a broad spectrum of industries.
